ON 07/02/2008 AT APPROXIMATELY 07:45 P.M. ON U.S.27/S.R.25 APPROXIMATELY 500 FEET SOUTH OF POLO PARK BLVD. EAST, IN THE DAVENPORT AREA OF POLK COUNTY FLORIDA THE SUSPECT (LISA REILLY) WAS DRIVING A VEHICLE NORTHBOUND. THE VEHICLE WAS REGISTERED TO THE SUSPECT'S HUSBAND (PAUL REILLY). THE VEHICLE WAS A 2003 FORD EXPLORER XLT THAT WAS RED IN COLOR. THE VEHICLE BORE FL. TAG T725SM WITH V.I.N. 1FM2UG3K33UB13932.

THE WITNESS WAS DRIVING A TRACTOR TRAILER NORTHBOUND IN THE OUTSIDE LANE OF U.S.27/S.R.25. THE WITNESS ADVISED THAT HE SAW THE SUSPECT DRIVE ONTO THE RIGHT/EAST GRASS SHOULDER AND PASS HIS VEHICLE. THE WITNESS SAID HE WAS TRAVELING 50 M.P.H. IN A 55 M.P.H. ZONE. THE VICTIM WAS WALKING NORTHBOUND ON THE RIGHT/EAST GRASS SHOULDER. THE WITNESS OBSERVED THE RIGHT FRONT OF THE SUSPECT VEHICLE IMPACT THE VICTIM. THE VICTIM WAS THROWN APPROXIMATELY 70 FEET NORTH. THE VICTIM SUFFERED FATAL AT SCENE INJURIES. THE VEHICLE RECEIVED EXTENSIVE DAMAGE TO THE RIGHT FRONT FENDER AND RIGHT BUMPER. THE GRILL WAS DAMAGED AS WELL AS THE RIGHT HEADLIGHT AND RIGHT TURN SIGNAL. THE LIGHT PIECES WERE RECOVERED AT THE SCENE.

THE WITNESS SAW THE SUSPECT VEHICLE CONTINUE NORTHBOUND ON THE GRASS SHOULDER, TURN RIGHT ONTO POLO PARK EAST BLVD. AND ENTER THE KANGAROO/CITGO STORE PARKING LOT. UPON ENTERING THE PARKING LOT, VIDEO FROM THE STORE RECORDED THE SUSPECT AND SUSPECT VEHICLE.

THE SUSPECT ENTERED A PARKING SPACE IN FRONT OF THE STORE AND REMAINED THERE MOMENTARILY. THEN BACKED OUT OF THE SPACE AND PULLED FORWARD STOPPING AT A FUEL PUMP AS IF TO PUMP GAS. THE WITNESS WHO HAD STOPPED HIS TRUCK ON U.S.27 APPROACHED THE SUSPECT ON FOOT. THE SUSPECT WAS SEEN ON VIDEO EXITING HER VEHICLE AND WALKING BEHIND IT AND APPROACHING THE GAS PUMP HOSE. THE WITNESS ADVISED HER THAT SHE HAD HIT A PERSON THAT WAS WALKING ON THE GRASS SHOULDER OF U.S.27. THE SUSPECT DENIED THIS AND TOLD THE WITNESS THAT WAS NOT ME, IT WAS A DIFFERENT RED S.U.V. THE WITNESS CALLED TO A STORE CLERK TO WRITE DOWN THE TAG NUMBER AND THE SUSPECT REENTERED HER VEHICLE AND EXITED THE PARKING LOT AT A HIGH RATE OF SPEED TO THE NORTH. THE WITNESS OBSERVED THE SUSPECT TURN FROM POLO PARK BLVD EAST TO SOUTHBOUND U.S.27/S.R.25 AND FLEE PAST THE VICTIM WITHOUT STOPPING AND RENDERING AID.

THE VIDEO REVEALED A RED FORD EXPLORER WITH EXTENSIVE RIGHT FRONT FENDER AND HOOD DAMAGE. THE HOOD WAS BUCKLED AND RAISED APPROXIMATELY 1 FOOT ABOVE NORMAL. THE VIDEO REVEALED A BROKEN GRILL, RIGHT FRONT BUMPER, RIGHT HEADLIGHT AND TURN SIGNAL. THE VIDEO SHOWED 5 SPOKE ALUMINUM WHEELS WITH LIGHT TRIM AROUND THE WHEEL WELLS AND BOTTOM OF THE DOORS/FENDERS. THE VIDEO SHOWS RUNNING BOARDS AND LUGGAGE RACK. THE CROSS SLATS OF THE LUGGAGE RACK WERE ABSENT. FORD PARTS PERSONELL WERE SHOWN THE VIDEO AND ADVISED THE VEHICLE WAS BETWEEN THE MODEL YEARS OF 2002 AND 2005. FORD PERSONELL SAID THE VEHICLE WAS EITHER A MODEL XLT, LIMITED OR EDDIE BAUER EDITION. VIDEO REVEALED THE SUSPECT DRIVER AS A WHITE FEMALE APPROXIMATELY 5 FEET TALL WITH BLONDE, STRAIGHT HAIR AT A LENGTH BETWEEN THE SHOULDER AND ELBOW, VERY THIN AND WEARING BLUE SHORTS AND A REDDISH PINK TOP. THE WITNESS ADVISED THE TAG WAS T7255N OR 2775N. NEITHER TAG WAS IN THE REGISTRATION SYSTEM.

VARIATIONS OF THE TAG REVEALED THAT TAG T7255M WAS REGISTERED TO PAUL REILLY AT [REDACTED] CORDOVA AV. DAVENPORT, WHICH IS LOCATED LESS THAN 5 MILES FROM THE CRASH SCENE. D.A.V.I.D. REVEALED THAT A FEMALE OF THE SAME LAST NAME AND SAME ADDRESS MATCHED THE SUSPECT DESCRIPTION. ONCE CONTACT WAS MADE AT CORDOVA AV. THE VEHICLE WAS FOUND TO MATCH THE DESCRIPTION INCLUDING THE DAMAGED AREAS. THE REILLY/SUSPECT VEHICLE IS A 2003 XLT FORD EXPLORER.

CONTACT WAS MADE AT THE REILLY RESIDENCE. PAUL REILLY ALLOWED DEPUTIES TO OBSERVE THE SUSPECT VEHICLE THAT WAS IN THE GARAGE. PAUL REILLY SAID HIS WIFE LISA REILLY (SUSPECT) HAD TOLD HIM THAT SHE HAD HIT A SEMI TRUCK SOMEWHERE ON U.S.27 WEDNESDAY 07/02/2008. I CONTACTED LISA REILLY AND ADVISED HER OF MIRANDA.

POST MIRANDA SUSPECT (LISA REILLY) SAID THAT ON 07/02/2008 THAT WHILE TRAVELING ON HWY 27 IN THE FAST LANE, SHE CHANGED LANES INTO THE SLOW RIGHT LANE AND HIT THE LADY, BUT SHE THOUGHT SHE HIT THE TRUCK. THE SUSPECT SAID SHE PULLED INTO THE KANGAROO/CITGO PARKING LOT TO CHECK HER VEHICLE. THE SUSPECT SAID A MAN APPROACHED HER YELLING AT HER AND SAYING SOMETHING ABOUT HER TAG. THE SUSPECT SAID SHE WAS SCARED AND LEFT TRAVELING SOUTH ON 27 TO HER HOME.
