**NARRATIVE** The undersigned certifies and swears that there is probable cause to believe the above named defendant, on the 10 day of October, 2008, at approximately 7:30 a.m. at 1250 Recc Canal Rd within Volusia County, violated the law and did then and there:

found in possession of a firearm on the campus of Atlantic High School. The firearm, a Cobra 380 caliber automatic, was found inside one of two of the defendant's book bag. He was also found in possession of a green leafy substance that tested positive for marijuana. At approximately 0723 hours, this Deputy received a phone call from the defendant's mother who reported she was missing her firearm. She requested that this Deputy search the defendant. Class had not begun; therefore, this Deputy requested, via school radio, for school personal to look for the defendant and transport him to the Discipline Office. Campus Advisor Wilkerson escorted to the Discipline Office. As this Deputy was entering the office, Wilkerson informed this Deputy that the defendant had two book bags. The defendant was the only student in the office. A small pink Strawberry Shortcake Berry Sporty book bag was found a short distance from the defendant. He had another larger Strawberry Sweet book bag sitting next to him. He denied having knowledge of being in possession of a firearm. This Deputy opened the smaller bag and found a black gun zipped gun case. The gun case was the only item inside the bag.
